GOVERNMENT OF THE RUSSIAN FEDERATION RESOLUTION

from October 7, 2022 No. 1787

On approval of the Rules for the implementation of control at the production sites (including processing), shipment of quarantine products intended for import into the Russian Federation for the purpose of their use for sowing and planting from foreign states or groups of foreign states, where the spread of quarantine objects characteristic of such quarantine products has been identified, in accordance with international treaties of the Russian Federation

In order to implement Part 3 of Article 15 of the Federal Law "On Plant Quarantine", the Government of the Russian Federation decrees:

- 1. To approve the attached Rules for the implementation of control at the production sites (including processing), shipment of quarantine products intended for import into the Russian Federation for the purpose of their use for sowing and planting from foreign states or groups of foreign states, where the spread of quarantine objects characteristic of such quarantine products has been identified, in accordance with international treaties of the Russian Federation.
- 2. The powers provided for by this resolution shall be implemented by the Federal Service for Veterinary and Phytosanitary Surveillance within the limits of the maximum number of its employees established by the Government of the Russian Federation and budgetary allocations provided to the Service in the federal budget for management and administration in the sphere of established functions.
- 3. To declare to be no longer in force the Resolution of the Government of the Russian Federation of February 8, 2018 No. 128 "On approval of the Rules for the implementation of control at the production sites (including processing), shipment of quarantine products intended for import into the Russian Federation from foreign states or groups of foreign states, where the spread of quarantine objects characteristic of such quarantine products has been identified, in accordance with international treaties of the Russian Federation, for the purpose of their use for sowing and planting" (Legislative Corpus of the Russian Federation, 2018, No. 8, Art. 1205).
 - 4. This resolution shall enter into force on 1 March 2023.
 - 5. The rules approved by this resolution shall be valid until March 1, 2029.

В целях реализации части 3 статьи 15 Федерального закона "О карантине растений" Правительство Российской Федерации постановляет:

- 1. Утвердить прилагаемые Правила осуществления контроля в местах производства (в том числе переработки), отгрузки подкарантинной продукции, предназначенной для ввоза в Российскую Федерацию в целях ее использования для посевов и посадок из иностранных государств или групп иностранных государств, где выявлено распространение карантинных объектов, характерных для такой подкарантинной продукции, в соответствии с международными договорами Российской Федерации.
- 2. Реализация полномочий, предусмотренных настоящим постановлением, осуществляется Федеральной службой по ветеринарному и фитосанитарному надзору в пределах установленной Правительством Российской Федерации предельной численности ее работников и бюджетных ассигнований, предусмотренных Службе в федеральном бюджете на руководство и управление в сфере установленных функций.

RULES for the implementation of control at the production sites (including processing), shipment of quarantine products intended for import into the Russian Federation for the purpose of their use for sowing and planting from foreign states or groups of foreign states, where the spread of quarantine objects characteristic of such quarantine products has been identified, in accordance with international treaties of the Russian Federation

- 1. These Rules establish the procedure for implementing control at the production sites (including processing), shipment of quarantine products intended for import into the Russian Federation for the purpose of their use for sowing and planting from foreign states or groups of foreign states, where the spread of quarantine objects characteristic of such quarantine products has been identified, in accordance with international treaties of the Russian Federation (hereinafter, respectively, the places of production of quarantine products, quarantine products, foreign state).
- 2. These Rules shall not apply to quarantine products intended for import into the Russian Federation from member states of the Eurasian Economic Union.
- 3. Control at the production sites of quarantine products is carried out by the Federal Service for Veterinary and Phytosanitary Surveillance (hereinafter referred to as the supervisory authority).
- 4. When carrying out control at the production sites of quarantine products, the quarantine phytosanitary state of the quarantine products, the quarantine phytosanitary state of the territory of a foreign state and (or) the production sites of quarantine products are identified.
- 5. Control at the production sites of quarantine products is carried out upon receipt by the supervisory authority of:
- a) an application from a participant of foreign economic activity regarding start of supplies of quarantine products from a foreign state for the purpose of carrying out control at the places of production of quarantine products, submitted in the form in accordance with Appendix No. 1 (hereinafter referred to as an application from a participant of foreign economic activity);
- b) an appeal (invitation) from an authorized body for plant quarantine of a foreign state (hereinafter referred to as "an authorized body of a foreign state"), submitted in any form.
- 6. An application from a participant of foreign economic activity shall be submitted to the supervisory authority through the federal state information system for issuing and recording phytosanitary documentation (the system for recording of issued phytosanitary documents in the field of plant quarantine) (hereinafter referred to as "the information system for issuing and recording phytosanitary documentation") or the federal state information system "Single Portal of State and Municipal Services (Functions)" (hereinafter referred to as "the Single Portal").

- 7. When carrying out control at the production sites of quarantine products in the case specified in subparagraph "a" of paragraph 5 of these Rules, the following documents in electronic form shall be attached to the application of the participant of foreign economic activity:
 - a) a contract for the supply of quarantine products (if any);
- b) a schedule for the supply of quarantine products (if any), which for the purposes of these Rules is understood to be a document containing information on the expected volumes, timing and locations of supplies of quarantine products, indicating the period of shipment from a foreign state, import into the territory of the Russian Federation, sowing and (or) planting sites, and accumulation sites of quarantine products (with postal addresses) (if any).
- 8. The supervisory authority shall make a decision to refuse to consider the application of a participant of foreign economic activity if it and the documents attached to it contain false information.

Notification of refusal to consider an application from a participant in foreign economic activity shall be sent to the participant in foreign economic activity no later than 1 working day from the date of receipt of the application from the participant of foreign economic activity through the information system for issuing and recording phytosanitary documentation or a single portal.

A participant in foreign economic activity has the right to reapply to the supervisory authority with an appeal of a participant in foreign economic activity after eliminating the reasons for the refusal to consider the appeal of a participant in foreign economic activity.

9. The supervisory authority, within 15 working days from the date of receipt of the application from the participant in foreign economic activity and the appeal from the authorized body of the foreign state, makes a decision on conducting control at the production sites of quarantine products.

The supervisory authority requests from the authorized body of a foreign state or other competent body of a foreign state information necessary for conducting control at the places of production of quarantine products.

- 10. Control at the production sites of quarantine products is carried out by means of the following quarantine phytosanitary measures:
 - a) inspection, sampling (samples) and laboratory testing of quarantine products;
- b) inspection and monitoring of production sites of quarantine products on the territory of a foreign state in order to establish their phytosanitary status in accordance with the provisions of the International Plant Protection Convention (Rome, 1951, as amended in 1997);
- c) analysis of documentation containing information on the phytosanitary condition of the production sites of quarantine products, the phytosanitary condition of the quarantine products, their origin, range and planned quantity of such quarantine products prepared for shipment to the Russian Federation.

- 11. The supervisory authority, with the consent and in cooperation with the authorized body of a foreign state, shall conduct joint control at the production sites of quarantine products of the application of quarantine phytosanitary measures, the condition of quarantine products and the places of production of quarantine products with the sampling (in 3 repetitions) of products, the substrate, which includes soil, peat and other organic substances. One sample is sent to organizations subordinate to the supervisory authority, the second to the plant quarantine laboratories of the authorized body of the foreign state, the third for the conduct of arbitration opinions (stored in the supervisory authority).
- 12. After establishing, within the framework of control of production sites of quarantine products, the quarantine phytosanitary state of quarantine products and production sites of quarantine products, the supervisory authority shall make one of the following decisions:
- a) refuses to import quarantine products into the Russian Federation if quarantine objects are identified as a result of laboratory tests;
- b) permits the import of quarantine products into the Russian Federation if quarantine objects are not identified based on the results of laboratory tests.
- 13. In relation to the production sites of quarantine products from the list in accordance with Appendix No. 2, control is carried out by means of documentary verification without carrying out the measures provided for in subparagraphs "a" and "b" of paragraph 10 and paragraph 11 of these Rules, with the exception of the case specified in paragraph 15 of these Rules.

The documentary verification includes an analysis of information received from the authorized body of a foreign state, as well as information available to the supervisory body, on the phytosanitary condition of the places of production of quarantine products, the phytosanitary condition of the quarantine products specified in Appendix No. 2 to these Rules, their origin, range and planned quantity of such quarantine products prepared for shipment to the Russian Federation.

- 14. Based on the results of monitoring the production sites of quarantine products through documentary verification, the supervisory authority shall make one of the following decisions:
- a) in case of an absence of information on the spread of quarantine objects in the production sites of quarantine products or confirmation by the authorized body of a foreign state of information on the absence of quarantine objects in the production sites of quarantine products, permits the import into the Russian Federation of quarantine products specified in the application of a participant in foreign economic activity from the production sites of quarantine products;
- b) if the application from a participant in foreign economic activity contains false information and/or if the supervisory authority receives information from an authorized body of a foreign state about the spread of quarantine objects at the place of production of quarantine products, it shall refuse importation of quarantine products from such place of production of quarantine products into the Russian Federation.
- 15. If quarantine objects included in the unified list of quarantine objects of the Eurasian Economic Union, approved by Decision of the Council of the Eurasian Economic Commission

dated November 30, 2016 No. 158 "On Approval of the Single List of Quarantine Objects of the Eurasian Economic Union", are detected in the quarantine products specified in Appendix No. 2 to these Rules, when imported into the territory of the Russian Federation in accordance with the Rules for the Implementation of State Quarantine Phytosanitary Control (Supervision) at Checkpoints across the State Border of the Russian Federation, approved by Decree of the Government of the Russian Federation of August 13, 2016 No. 792 "On the Procedure for Implementing State Quarantine Phytosanitary Control (Supervision) at Checkpoints across the State Border of the Russian Federation", quarantine objects included in the single list of quarantine objects of the Eurasian Economic Union, approved by Decision of the Council of the Eurasian Economic Commission dated November 30, 2016 No. 158 "On Approval of the Single List of Quarantine Objects of the Eurasian Economic Union", the measures provided for in paragraphs 10 and 11 of these Rules shall be carried out at the production sites of the quarantine products.

The measures provided in paragraphs 10 and 11 of these Rules, in relation to the production sites of quarantine products in the case specified in the first paragraph of this paragraph, are carried out on the basis of an application from a participant of foreign economic activity in relation to the said places of production of quarantine products and are carried out until the supervisory authority makes the decision provided for in subparagraph "b" of paragraph 12 of these Rules, followed by a documentary inspection provided for in paragraph 13 of these Rules.

Based on the results of control at the production sites of quarantine products specified in Appendix No. 2 to these Rules, in relation to which the measures provided for in paragraphs 10 and 11 of these Rules were carried out, one of the decisions provided for in paragraph 12 of these Rules shall be made.

16. The decisions specified in subparagraph "a" of paragraph 12 and subparagraph "b" of paragraph 14 of these Rules shall be sent to the authorized body of the foreign state through the information system for issuing and recording phytosanitary documentation, and to participants in foreign economic activity - through the information system for issuing and recording phytosanitary documentation or a single portal within a period not exceeding 5 working days after the adoption of such a decision.

17. In case of disagreement with the authorized body of a foreign state, an arbitration sample of the quarantine product and (or) substrate, which includes soil, peat and other organic substances, is sent by the supervisory body to an independent plant quarantine laboratory. The decision on the import of quarantine products into the Russian Federation is made by the supervisory body in accordance with the provisions of the International Plant Protection Convention (Rome, 1951, as amended in 1997).

18. After completing the implementation of control at the production sites of quarantine products, the supervisory authority shall prepare a report containing information on the quarantine phytosanitary condition of the quarantine products and (or) production sites of quarantine products that comply with the quarantine phytosanitary requirements of the Russian Federation.
